In 2024, we added five providers in areas that included acute rehabilitation, cardiology, general surgery, interventional radiology, and psychiatry.

Investments in our facilities – from infrastructure to the latest healthcare technology – ensure that our hospital can continue to meet the community’s evolving healthcare needs. Last year, we spent more than \$3.7 million on capital improvements that included nursing monitors, a reverse osmosis filtration system, surgical instruments and equipment, and new ventilators for critical ICU patients.
